WHEREAS, the Board of Directors of the Dorr Street Joint Economic Development District desires to contract with the Township for administrative or employee services to be provided to the District, and the Township desires to contract with the Board of Directors of the Dorr Street Joint Economic Development District to provide administrative and clerical services to the District in accordance with the terms set forth in the Agreement Between Dorr Street Joint Economic Development District and Springfield Township, Lucas County, Ohio for Administrative and Clerical Assistance attached hereto as Exhibit A; and

WHEREAS, it is in the best interests of Springfield Township to provide administrative and clerical assistance to the District

**NOW THEREFORE, BE IT RESOLVED** by the Board of Trustees of Springfield Township, Lucas County, Ohio:

1. That the Agreement Between Dorr Street Joint Economic Development District and Springfield Township, Lucas County, Ohio for Administrative and Clerical Assistance substantially in the form attached hereto as Exhibit A and incorporated herein by reference hereby is approved, with such changes that are not inconsistent with this Resolution, are not substantially adverse to the Township and are approved by the Township Administrator and Law Director, all of which shall be evidenced conclusively by the execution of the Agreement Between Dorr Street Joint Economic Development District and Springfield Township, Lucas County, Ohio for Administrative and Clerical Assistance by the Trustees.
