TO PETITION BOARD OF THE LUCAS COUNTY COMMISSIONERS TO DESIGN AND CONSTRUCT A WATERCOURSE IMPROVEMENT TO ZINK-HELDMAN DITCH AND GEISER DITCH AND TO REQUEST THE BOARD OF LUCAS COUNTY COMMISSIONERS TO ESTABLISH THE IMPROVEMENT AS A PUBLIC WATERCOURSE

The Board of Trustees of Springfield Township, Lucas County, Ohio, met in Regular Session on March 16, 2020, at 7617 Angola Road, Holland, Ohio, with the following members present:

Robert Bethel, Tom Anderson Jr. and Andrew Glenn

Robert Bethel moved the adoption of the following Resolution:

WHEREAS, Ohio Revised Code section 6131.04 permits the owner of an interest in land to petition the Board of Lucas County Commissioners to construct any ditch improvement to remove surplus water from an area; and

WHEREAS, having an interest in the right-of-way benefitting from said ditch improvements the Board of Trustees of Springfield Township, Lucas County, Ohio can file a petition to the Board of Lucas County Commissioners requesting such improvements; and

WHEREAS, the Board of Trustees seeks ditch improvements to the areas known as, or to be known as, Zink-Heldman Ditch and Geiser Ditch to control surplus water; and

WHEREAS, all costs of engineering, construction, and maintenance will be assessed to the benefitted parcels of land, except as ordered under Section 6131.31 of the Ohio Revised Code. However, at this time, it is planned the assessments will be paid through the Lucas County Stormwater Utility. After completion of the project, the petition request the Board of Lucas County Commissioners to declare said improvement as a public watercourse and place said ditch improvement under permanent maintenance after construction.

NOW THEREFORE, BE IT RESOLVED by Springfield Township Board of Trustees, Lucas County, Ohio:

- 1. That the Board hereby petitions the Board of Lucas County Commissioners for ditch improvements in a manner deemed to be the most conducive to the public welfare of the above described watercourses known as Zink-Heldman Ditch and Geiser Ditch utilizing any, all, or a combination of the methods provided for in Ohio Revised Code Section 6131.01 (C)(1)-(5) necessary for the control and disposal of surplus water.
- 2. That the course and termini of the proposed ditch improvements are as follows:

Zink-Heldman Ditch: Commencing at the westerly line of Plum Grove Subdivision in Springfield Township then conversing northwesterly and ending at Bancroft Street in Springfield Township, a total distance of 8,560 feet.

Geiser Ditch: Commencing at the confluence of Heldman Ditch then conversing westerly to its termination in Springfield Township, a total distance of 2,260 feet

3. That the construction of the improvement is necessary, will benefit the petitioner and will be conducive to the public welfare.

DISHONESTY AND FAITHFUL PERFORMANCE OF DUTY POLICY IN LIEU OF SURETY BOND

The Board of Trustees of Springfield Township, Lucas County, Ohio, held a Special Session by teleconference under authority of Section 12 of Amended Substitute House Bill Number 197, 133rd Ohio General Assembly, 2019-2020, on March 30, 2020, at 6:00 p.m., with the following members participating in the teleconference and therefore considered present as if in person:

Andrew Glenn moved the adoption of the following Resolution:

WHEREAS, Ohio Revised Code §3.061(B) permits a township to allow for the use of an employee dishonesty and faithful performance of duty policy, rather than a surety bond, to cover losses caused by the fraudulent or dishonest actions of, and the failure to perform a duty prescribed by law for, officers, employees, or appointees that otherwise would be required to give an individual surety bond to qualify for the office or employment before entering upon the discharge of duties imposed by the office or employment; and

WHEREAS, "employee dishonesty and faithful performance of duty policy" means a policy of insurance, or a coverage document issued by a joint self-insurance pool authorized under Ohio Revised Code §2744.081, to protect a political subdivision from financial or property loss caused by the fraudulent or dishonest actions of, and the failure to perform a duty prescribed by law for, an officer, employee, or appointee that otherwise is required by law to give an individual surety bond before entering upon the discharge of official duties; and

WHEREAS, the Board of Trustees has determined that it is in the best interests of Springfield Township, its officers, employees and appointees to use an employee dishonesty and faithful performance of duty policy to protect Springfield Township from financial or property loss caused by the fraudulent or dishonest actions of, and the failure to perform a duty prescribed by law for, an officer, employee, or appointee that otherwise is required by law to give an individual surety bond before entering upon the discharge of official duties; and

WHEREAS, Springfield Township currently maintains an employee dishonesty and crime insurance policy from Ohio Plan Risk Management, which is a joint self-insurance pool authorized under Ohio Revised Code §2744.081; and

WHEREAS, employee dishonesty and faithful performance of duty policy coverage is available from Ohio Plan Risk Management by endorsement, amendment or otherwise to the current Springfield Township employee dishonesty and crime insurance policy.

DISHONESTY AND FAITHFUL PERFORMANCE OF DUTY POLICY IN LIEU OF SURETY BOND

NOW THEREFORE, BE IT RESOLVED by the Springfield Township, Lucas County, Ohio Board of Trustees:

- 1. That the Board of Trustees hereby adopts a policy to allow for the use of an employee dishonesty and faithful performance of duty policy, rather than a surety bond, to cover losses caused by the fraudulent or dishonest actions, and the failure to perform a duty prescribed by law for, officers, employees, or appointees that otherwise would be required to give an individual surety bond to qualify for the office or employment before entereing upon the discharge of duties imposed by the office or employment.
- 2. That the employee dishonesty and faithful performance of duty policy shall cover all officers, employees, or appointees of Springfield Township that otherwise are required by law to give an individual surety bond before entering upon the discharge of official duties, subject to the transition provisions in Item 5, below.
- 3. That the employee dishonesty and faithful performance of duty policy shall be in effect and apply to the officer, employee, or appointee before the beginning of the individual's term of office or employment, and the officer, employee or appointee shall not commence the discharge of duties until coverage is documented by the Township.
- 4. That Springfield Township add or obtain employee dishonesty and faithful performance of duty policy coverage by endorsement, amendment or otherwise from Ohio Plan Risk Management or other qualifying insurance carrier under Ohio Revised Code §3.061, and thereafter continuously maintain such type of coverage with limits of coverage in the minimum amount of Three Hundred Thousand Dollars (\$300,000.00) per incident.
- 5. That current officers, employees and appointees of Springfield Township as of the date of adoption of these Resolutions who are required by law to give an individual surety bond to qualify for the office or employment shall maintain their existing surety bonds until the end of their respective terms of office, employment or appointment.
- 6. That the Springfield Township Administrator and Fiscal Officer hereby are authorized to effect all policies and procedures necessary to carry out these Resolutions and administer the terms of the employee dishonesty and faithful performance of duty policy in accordance with these Resolutions.
