## <u>PLANNING AND ZONING</u>: By Jacob Barnes, Planning Director Written Report:

- Mr. Barnes expressed his thanks to Mrs. Yoder for all her support throughout the years that they worked together.
- 18 permits were issued in the month of November, including four new dwellings and one new business.
- At their November 27, 2017 meeting, the Board of Zoning Appeals approved a variance request for accessory building square footage and number submitted by Anthony & Pauline Wallace for the property located at 2727 Gunn Road.
- On November 2, 2017, preliminary site plan approval was granted for a new Landscape Contractor at 8060 Garden Road.
- Mr. Barnes attended the NW Ohio APA Conference on November 18, 2017 and was a speaker for their 90-minute zoning panel.
- Met with Greg Repass and developers concerning development at Airport Hwy and Albon Road.
- The Planning Department continues to distribute our new Business Survey as part of our business outreach program. In November, five business meetings were completed with surveys being passed out. Good feedback continues to be received.
- Mr. Barnes presented the Trustees with a request to initiate a proposed text amendment.
