Lt. Leach presented his monthly report and stated that his officers continue to see an increase in traffic with the warm weather and the relaxation of the coronavirus restrictions. He also said that they have been present for a number of Black Lives Matter demonstrations, mostly peaceful.

Fire/EMS Report: By Chief Cousino, Fire Chief

Chief Cousino reviewed the Monthly Report and highlighted the following items:

• Chief Cousino stated that non-COVID-19 calls actually decreased during the pandemic, as residents only contacted EMS for major emergencies.

- Chief Cousino attended a meeting with all related parties to discuss how to respond to emergencies on the Turnpike during upcoming construction.
- The Northwest Ohio Fire Chiefs Association have resumed their monthly meetings in virtual form.
- Chief Cousino was appointed to serve on the Lucas County 911 Regional Council of Government by the Lucas County Township Association.
- The annual fire extinguisher inspections and servicing were completed.
- Three smoke detectors were installed during the month.
- The Fire Department has been performing courtesy drive by parades to help local children celebrate their birthdays during the pandemic. The service will continue until June 15th.
- Fire/EMS responded to 277 calls in the month of May, of which 43 were in the Village of Holland, 21 in Spencer Township, 7 in Swanton Township, and 13 in Harding Township.

Mr. Hohlbein reviewed the Monthly Report and highlighted the following items:

- Employees completed routine mowing along the side of roads and around guardrails.
- The 2020 Street Sweeping recertification has been completed.
- A drainage pipe on Old Airport Highway had to be replaced after a recent storm. The Township coordinated the repair but the County will pay for it under the Storm Water Utility program.
- The 2020 crack seal program has been completed.
- All park facilities are now open and available for use.
- There were nine burials and six graves sold during the past month.
- Routine maintenance was performed on Fire Station #52 and Medic Unit #56.
- New cleaning procedures have been developed for the Hall to ensure that the facility is properly sanitized between uses.
- Public hearing and no parking signs were posted in several locations.
