The Springfield Township Trustees met in regular session, open to the public, on Monday, November 4, 2019, at 7:00 p.m. in the Township Chambers, 7617 Angola Road, Holland, Ohio with the following members present:

Robert Bethel called the meeting to order at 7:00 p.m. All present were asked to rise for a moment of silence and the Pledge of Allegiance.

PUBLIC COMMENT:

Mr. Matthew Fitzgibbons, 7519 Dorr Street, Lot 108, updated the Trustees on his ongoing battle to get owners of Royal Village to address the health and safety issues in the Mobile Home Park. He stated that although he has asked for help from all the responsible regulatory agencies and placed his rent payments in escrow until the infractions are corrected, the owners of the Park still continue to violate the state regulations. Mr. Fitzgibbons said his next move was to present his case in court and asked the Trustees for some statement of their support. The Trustees said that they would review the facts and help in whatever way they could.

Mr. Jim Norton, 7927 E. Hidden Harbor, said that he though the branding on the McCord St. railroad overpass was in need of repair and would be more visible in a darker color. The Trustees said that that issue had already caught their attention and options were being discussed.

<u>PUBLIC SERVICES:</u> By Andy Hohlbein, Director of Public Services Mr. Hohlbein presented the Trustees with a draft agreement with Lucas County to enclose the ditch along Geiser Road. He explained that this project must be completed before work can begin on the Township's 2020 OPWC project. All costs will be paid through the Storm Water Utility Fund.
