PUBLIC ADMINISTRATION: By Mike Hampton, Administrator

- Written Report:
 - Mr. Hampton reported that Lt. Leach investigated the complaint lodged by Jill Eide at the
 last Trustee meeting (see public comment section). The Lieutenant stated that an officer
 did drive through the Eide's neighborhood during the evening and also initiated a follow
 up call with them, but no one answered the phone and there was no voicemail available to
 leave a message.
 - The residential PACE program, originally expected to be rolled out this year but delayed due to the pandemic, should be available in 2021. The program provides low cost, long term financing for energy efficiency improvements.
 - Mr. Hampton is working to ensure that the Township's bike path project on Airport Highway, due to be completed in the next few years, is complementary with other intersection improvements planned for the 2026 through 2028 time period.
 - The Township's bridge enhancement project is expected to be completed in the next few weeks. The new fencing is being installed currently.
 - The Ohio legislature extended the time frame allowing for virtual Trustee meetings, through the middle of 2021.
 - The Lucas County Township Association elections are scheduled for December 12th.
 - The TMACOG General Assembly will be held on January 19th in a virtual format. The Township sessions are scheduled for several days later on January 21st.
