### PUBLIC ADMINISTRATION: By Mike Hampton, Administrator

Mr. Hampton presented the Monthly Report and highlighted the following items:

- The Township has given temporary permission for refuse haulers to use Pilliod Road during the Holland-Perrysburg bridge closure, with the condition that they respect load limits and repair any damage that their vehicles cause.
- Additional signage will be placed along residential streets that might be used as an unofficial, alternate route to bypass the upcoming Angola/King intersection closure.
- The EMA siren has been relocated to Community Homecoming Park.
- The County Floodplain Manager will send letters to the residents of Sawmill Run asking them to remove all structures from the floodplain/floodway (see Trustee Meeting minutes of 5/16/22 Public Administration). The letter will also explain how they can request a variance for existing or future structures, if permissible by law.
- A local scouting group will be completing their annual drain stenciling in the Township.
- The Department of Commerce is continuing to pursue multiple, significant complaints against the owners of Royal Village. It also appears that, with a change to our zoning regulations, it may be possible for the Township to exert more local control over mobile home communities.
- The Freedom Celebration is scheduled for July 2<sup>nd</sup>.
