Sheriff's Report: By Sgt. Shrewsberry

Sgt. Shrewsberry presented the JEDZ Holiday Patrol summary. Overall, 115 incidents were responded to during the 2022 holiday season. Assistant Fire Chief Moore also stated that the additional police presence was of great assistance to the Fire Department.

#### PUBLIC SAFETY (cont.):

Fire/EMS Report: By Dave Moore, Assistant Fire Chief

Chief Moore reviewed the December Monthly Report and highlighted the following items:

- Chief Moore attended a webinar discussing data collection strategies for the new, mandated Centers for Medicare and Medicaid Services (CMS) reporting system.
- Captain Kokocinski transported Santa Claus to the annual tree lighting ceremony at Strawberry Acres.
- Smoke alarms were installed in a residence on Ginger Gold Drive.
- Promedica has requested that the Fire Department make an additional bay available during scheduled car seat fitting events, due to excessive demand.
- In house apparatus training was completed at the various fire stations.
- Chief Moore presented a variety of statistics on the number of calls, response times, and deficiency items for 2022. Although calls have increased by over 40% versus 2017, there was only a slight increase from last year. The Chief attributed much of this stability to the success of the HERO program.
- Fire/EMS responded to 446 calls in the month of December; 320 in Springfield Township, 51 in the Village of Holland, 21 in Swanton Township, 19 in Spencer Township, 6 in Harding Township, and 29 in other mutual aid communities.
