**WHEREAS**, Firefighter Schill has been involved in teaching numerous firefighters in firefighting tactics and has mentored and developed several firefighters over his career; and

**WHEREAS**, Firefighter James Schill through his different roles and responsibilities, has been instrumental in the protection of our community and personally responsible for saving countless lives over his 27 plus year career.

**THEREFORE, BE IT RESOLVED**, by the Springfield Township Board of Trustees:

Tom Anderson Jr. seconded the motion and the roll call was called on the question of its adoption. The vote was as follows:




