### **ACQUISITION OF FIRE APPARATUS**

WHEREAS, Springfield Township Board of Trustees (Lessee) has taken the necessary steps, including any legal bidding requirements, under applicable law to arrange for the acquisition of such equipment;

**NOW THEREFORE, BE IT RESOLVED** by the Board of Trustees of Springfield Township (Lessee) Lucas County, Ohio:

- 1. That the terms of said Lease-Purchase Agreement and Escrow Agreement are in the best interest of Springfield Township Board of Trustees (Lessee) for the acquisition of such equipment, and the governing body of Springfield Township Board of Trustees (Lessee) designates and confirms the following persons to execute and deliver, and to witness (or attest), respectively, **Leasing 2, Inc.** Lease-Purchase Agreement and Escrow Agreement, if applicable, and any related documents necessary to the consummation of the transactions contemplated by the Lease-Purchase Agreement and Escrow-Agreement.
- 2. Springfield Township Board of Trustees authorizes the Administrator of Springfield Township to enter into a 4-year lease Purchase Agreement with Leasing 2, Inc. to finance the purchase of a new fire pumper, Vacuum Truck, etc. in the amount of \$1,920,543 purchased from Sutphen.
