**TO ADOPT THE LUCAS COUNTY MULTI-JURISDICTIONAL HAZARD MITIGATION
PLAN (2024 UPDATE) DEVELOPED BY THE LUCAS COUNTY EMERGENCY
MANAGEMENT AGENCY**

The Board of Trustees of Springfield Township, Lucas County, Ohio, met in Regular Session on October 1, 2024, at 7617 Angola Road, Holland, Ohio, with the following members present:

Tom Anderson Jr. moved the adoption of the following Resolution:

WHEREAS, Lucas County, Ohio and its constituent jurisdictions have been and may be subject to hazards that have or could result in the loss of life, injuries, property and environmental damages, economic disruptions, and threats to public health and safety; and

WHEREAS, the Lucas County Emergency Management Agency and representatives of county and local governments have engaged in a risk assessment for various identified hazards, an inventory of critical facilities and at-risk areas, and the identification of methods to maintain and update a plan that identifies and evaluates risks and vulnerabilities from hazards that affect Lucas County and its constituent jurisdictions; and

WHEREAS, the participating parties have developed the Lucas County Multi-Jurisdictional Hazard Mitigation Plan (2024 Update) (the "Plan") applicable to all incorporated and unincorporated areas of Lucas County, which such Plan recommends many hazard mitigation actions to protect the people and property affected by natural hazards that face Lucas County; and

WHEREAS, Springfield Township participated in the development of the Plan; and

WHEREAS, the Board of Trustees has determined that it is in the best interests of the Township and the health, safety and welfare of its residents and occupants to approve and adopt the Plan.

NOW THEREFORE, BE IT RESOLVED by Springfield Township Board of Trustees, Lucas County, Ohio:

1. That the Board of Trustees approves and adopts the Lucas County Multi-Jurisdictional Hazard Mitigation Plan (2024 Update) (the "Plan") and participation therein by Springfield Township.
2. That the respective Township administration officials are directed reasonably to implement the provisions of the Plan applicable and beneficial to the Township in their discretion and to report regularly to the Trustees on their activities, accomplishments, and progress under the Plan.






