- Comments for or against the \$5,00 permissive license plate fee per ORC 4504.181
 - *Mike Hampton, Township Administrator, sworn in by Tom Anderson Jr.* – this permissive tax has been available since 2017; however, the board has intentionally delayed implementing this revenue measure. Now, recognizing a genuine need for additional funds, the board is choosing to generate a bit of extra revenue without needing to propose a road levy to the voters.
 - *Lamar Reese, 8228 South Anthony Drive, Holland, OH 43528, sworn in by Tom Anderson Jr.* – questioning since the permissive tax has been available since 2017, does the Township intend to retroactive the tax? Answer is no; it would be effective moving forward.


