NOTICE OF LIGHTING ASSESSMENT RE-CERTIFICATION

The Board of Trustees of Springfield Township, Lucas County, Ohio, met in regular session on September 2, 2025 at 7617 Angola Road, Holland, Ohio, with the following members present:

Andrew Glenn, Tom Anderson Jr., and Rachel Geiger

Andrew Glenn moved the adoption of the following Resolution:

WHEREAS, there are existing street lighting contracts and variable rates with Toledo Edison Company covering various lighting districts within the Township; and

WHEREAS, there is a continued need for said lighting to ensure the public safety and welfare of the residents; and

WHEREAS, the cost and expense of lighting these districts shall be assessed against the benefitted lots and parcels in the lighting districts; and

WHEREAS, a reassessment periodically must be submitted to the Lucas County Auditor based upon renewals, increases in rates, newly completed lighting districts, and splits and combinations that have occurred during the year.

THEREFORE, BE IT RESOLVED, by the Springfield Township Board of Trustees, Lucas County, Ohio in accordance with the Ohio Revised Code section 515.11:

1. That the lighting district costs and expenses for the current remaining contract years with Toledo Edison be, and they hereby are, reassessed against the benefitted lots and parcels in the amounts and for the years assessed as set forth on Exhibit A attached hereto for Lighting District 019P (Carmella Gardens), Lighting District 030P (Stone Oak Plats 1-6), Lighting District 101P (Plum Grove Plat 2), and Lighting District 107P (Plum Grove Plat 4) for years 2026 – 2030.
2. That the Township Fiscal Officer shall certify such reassessments to the Lucas County Auditor.
3. That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were adopted in an open meeting of this Board and that all deliberations of this Board that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Revised Code of Ohio.




