**RESOLUTION 25-031**

**RESOLUTION AUTHORIZING THE REMOVAL OF JUNK VEHICLES**

The Board of Trustees of Springfield Township, Lucas County, Ohio, met in Regular Session on November 4, 2025, at 7617 Angola Road, Holland, Ohio, with the following members present:

Rachel Geiger, Tom Anderson Jr., Andrew Glenn

Andrew Glenn moved the adoption of the following Resolution:

**WHEREAS**, *R.C. 505.871* authorizes a Board of Township Trustees to remove any junk vehicle from the unincorporated territory of the Township; and

**WHEREAS**, the vehicles described herein are junk vehicles, and;

**NOW THEREFORE, BE IT RESOLVED**, by Springfield Township Board of Trustees, Lucas County, Ohio,

1. This Board determines that the description of vehicles are attached hereto as Exhibit A located at 6854 Spring Valley Dr., Holland, Ohio are junk vehicles as defined in *R.C. 505.173(E)*;
2. If the owner(s) of the property located at 6854 Spring Valley Dr., Holland, Ohio fails to remove the junk vehicles described in Section 1 within fourteen days of receiving the notice of the Board's intention to remove, the Board hereby authorizes the [Township Police Chief, Fiscal Officer, Road Department] to remove the junk vehicles specified in Section 1.
3. The Fiscal Officer is hereby directed to send a notice of removal, in accordance with *R.C. 505.871(C)(3)*, by certified mail to the owner and holders of liens of record of the property specified above.
4. The Board further directs the Fiscal Officer to certify the expenses to remove the junk vehicle and a description of the property where it was located to the Lucas County Auditor to be placed upon the tax duplicate as a lien upon the property to be collected as other taxes and returned to the township general fund.
5. The Board finds and determines that all formal actions of this Board concerning and relating to the adoption of this resolution were taken in an open meeting of this Board and that all deliberations of this Board that resulted in those formal actions were in a meeting open to the public in compliance with the law.
6. This resolution shall be in full force and effect from and immediately upon its adoption






